# **Executive Summary**

This plan is the Public Transit-Human Services Transportation Plan for Hocking County, Ohio. The plan was developed in 2018 and updated in 2022. This plan fulfills the requirements of the Federal Transit Administration (FTA) Circular 9070.1G which purpose is to enhance mobility for seniors and individuals with disabilities.

Transportation is a critical component of the rural communities in Hocking County, Ohio. Transportation provides access to jobs, education, healthcare, human services and allows all community members, including older adults and people with disabilities, to live independently and engage in community life.

The purpose of a locally developed, coordinated public transit-human services transportation plan (coordinated plan) is to identify community resources for transportation and mobility, understand the transportation and mobility gaps and unmet needs, and determine the best approach to addressing them.

The Hocking County Coordinated Transportation Plan is continually reviewed and updated by utilizing participant representation from human services agencies, non-profit organizations and transportation providers, senior citizens, persons with disabilities, for-profit transportation providers, the public, mobility management and other key stakeholders. We have an advisory group that keeps this document current and relevant to assist in the effort to eliminate the transportation challenges and barriers in our community.

It is the purpose of this plan for local stakeholders to work collaboratively to do the following activities:

- 1. Identify all community resources including
  - Public door-to-door accessible van transportation providers
  - Senior transportation providers
  - Transportation for individuals with disabilities
  - Veteran transportation providers
  - Health and Human Services transportation providers
  - Inter-city bus transportation providers
  - Non-emergency medical transportation providers
  - Ride-share services
  - Taxi services
  - Bike path and lane access
  - Complete streets resources
  - Accessibility and safety of sidewalks and crossing areas
  - Pedestrian and transportation safety resources
  - Electric vehicle charging infrastructure
- 2. Identify and prioritize community transportation needs
  - Maintaining operating expenses amid rising expenses for fuel and maintaining older vehicles in fleet
  - Long distances/long hours for riders to be transported
  - Hiring/training/retaining drivers

- COVID protocols/exposure potential/illness
- Winter road conditions and driveway conditions
- Community members are not aware of transportation services in Hocking County
- Transportation options early morning, evening and weekends
- Coordination of services
- Creation of Hocking County Active Transportation Plan
- Creation of bike path network, linking to other neighboring counties
- Continuation of the Athens-Hocking Mobility Management Program
- Support for out-of-county affordable trips

#### 3. Establish a clear plan for achieving shared goals

Hocking County will continue to coordinate efforts with all transportation providers and community stakeholders to achieve the goals and needs as listed in the Coordinated Transportation Plan. Through partnerships and shared priorities, the county, cities, villages, residents, businesses, social service agencies and transportation providers will work together towards achieving the goals as stated in this document. The Athens-Hocking Mobility Management Program will utilize this plan as a roadmap for future transportation initiatives throughout the county and region.

Fundamental to the Coordinated Transportation Plan process is the active and meaningful involvement of stakeholders. For projects selected for funding under the Section 5310 program, participation in planning activities must include participation and/or representation of the following, at minimum:

- Seniors
- Individuals with disabilities
- People with low incomes
- Public, private and non-profit transportation providers

- Human services providers
- The general public
- Social service agencies
- Regional Planning organizations

In order to ensure participation from the above groups the following stakeholder involvement activities were performed:

Held public meetings in the county, attended community events with surveys, met with stakeholders, attended senior citizen events (MM is a member of the Scenic Hills Senior Center), led transportation talks at 4 DD organizations, and attended partner meetings as transportation representative. Meetings have been in-person for 2022.

The plan was developed and adopted by the Hocking County Coordinated Transportation Plan Steering Committee 2022 consisting of representatives from the following organizations:

- South Central Department of Job and Family Services



# I. Geographic Area

Geographically, Hocking County is located in Southeastern Ohio, in the Appalachian foothills region of the state. It has a total area of 424 square miles, of which 421 square miles is land and 3 square miles of water. 40% of the county is non-taxed State or Federal land. It features steep, rugged hills, deeply dissected by rocky cliffs & stream valleys. It p

Due to its location in the Alleghany Plateau, Hocking County has one of the most stunning rock and cave formations in the United States. The geographical formations are largely comprised of black hand sandstone, a unique variety that can be found in copious amounts in the region.

Hocking County spans 3 identified watersheds, The Hocking Watershed, The Lower Scioto Watershed & the Raccoon-Symmes Watershed. The Hock-Hocking river enters Hocking County from Good Hope Township in the northwest and then flows southwest, touches Marion Township, continues through Falls and Green Townships, and exits through northwestern Starr Township into Athens County.



US Route 33 spans from Athens County to Fairfield County cutting through the north central region of Hocking County. It continues to and through Columbus connecting to major Interstates 70 and 71 and beyond.

Hocking County is served by state routes and county roads that connect the villages and census designated areas such as Buchtel, Murray City, Laurelville, Hide-A-Way Hills, Haydenville & Carbon Hill. Due to the geology of the region these roads contain very sharp turns and steep hilly terrain with little lighting.

**Map 3: Map of Hocking County Public Lands** 



Most major trip generators in the County are located in the city of Logan. The county and hospital are the entities with highest number of employees in or near Logan. Major employers in the rural areas of the county are local schools (one main consolidated school district), strategically spread throughout the county to ensure that all areas are covered by a close district.

# II. Population Demographics

To better assess demand for transit services in Hocking County, specific characteristics of the population must be examined. Hocking County currently has an estimated total population of 28,097 individuals. Of the total population, roughly 7,349 reside in the City of Logan. Projections show a significant decline of population totals over a twenty-year period (2020-2040).





#### Chart 5: Number and percentage of households with incomes below the federal poverty level


Chart 5 demonstrates that families with no children present and married-couple families with their own children make up the majority of households with incomes below the federal poverty level.

# III. Assessment of Available Services

Conducting an evaluation of service provider capabilities and analyzing the existing gaps and duplications of services for transportation resources in each community, provides transportation planners with the information needed to implement changes that will improve the network of transportation resources and services in Hocking County and across county lines.

The lead agency identified stakeholders to participate in the assessment of available services. These stakeholders included those who were represented in the current or past planning committees, as well as others who the planning committee identified as being appropriate stakeholders.

Interviews were conducted with each of the identified stakeholders.

The purpose of the interview was to offer the stakeholders an opportunity to discuss the specific transportation services, gaps, needs, and priorities for their respective service areas or communities.

When applicable, information reported in the previous coordinated plan was used to supplement information gathered during this planning effort.

The purpose of the planning process (interviews, surveys, community meetings and communication outside of meetings) was to update the existing coordinated public transit-human services transportation plan for Hocking County that will:

- Increase support for coordinated transportation planning within Hocking County and with neighboring counties
- Identify the transportation gaps and barriers for Hocking County citizens, with an emphasis on senior citizens, people with disabilities and low income individuals
- Prioritize transportation services for funding
- Determine how new 5310 vehicles could help the county alleviate some transportation barriers/gaps.

# Assessment of Community Support for Transit

Lack of transportation has been, and continues to be, a very significant problem for people living in poverty, particularly for people in rural areas such as Hocking County where there are limited public transportation options.

Hocking County has long recognized the need for transportation services in the region and has a long history of overall support for transportation initiatives. Recognizing the need for the growth of transportation in the community Hocking County/City of Logan partnered with Hocking Athens Perry Community Action (HAPCAP) and the Ohio Department of Transportation (ODOT) to facilitate the Logan Public Transit project in 2007.

A transportation work group was formed known as the Hocking County Transportation Advisory Coalition. The Coalition undertook an extensive review of the transportation services in the county and identified strategies and priorities for addressing these needs. This group has continued to meet since in an advisory capacity. It has continued to advance the strategies highlighted in the initial coordinated transportation plan created in 2008 and remains dedicated to:

- Connecting its rural communities to The City of Logan and other parts of the state at affordable rates.
- Increasing understanding and awareness of community transportation needs
- Assisting individuals with accessing all community transportation options, particularly seniors, persons with disabilities and low income residents
- Increasing local capacity for transportation services
- Increasing awareness of current community transportation options and programs
- Establishing safe pedestrian & alternative travel infrastructure

Many organizations and entities are interested in transportation. The City of Logan has supported LPT financially since 2007 by providing local match. Numerous organizations have contracted with LPT. The Southern Ohio Center for Independent Living has long been a supporter of advancing transportation efforts in the community. Other organizations recognize it as an issue. The Health Department has been working on active transportation efforts and there interest in a group meeting to advance bike path expansion in the community.

# Safety

All transportation providers in Hocking County are dedicated to ensuring safe transportation for all riders, drivers, and pedestrians. Although the various providers require different safety courses for their drivers, there are requirements for each provider to ensure safe practices. Some of these trainings are:

Defensive driving, DRIVE (Driving older adults and individuals with disabilities), First aid, CPR, Passenger Assistance Techniques, etc. Some programs have their own training programs by certified trainers within their organizations.

The mobility manager can provide travel training to the public and those who request it. This is offered in a group setting or one-on-one. The MM also coordinates with the providers by informing them of training programs, workshops and shared classes offered in the area and the costs. The mobility manager is a trained CarFit Technician and PAT Trainer.

Those with 5310 ODOT vehicles adhere to the preventative maintenance program and keep their vehicles adequately serviced. Currently there are no 5310 vehicles in the county (2022).

As active transportation efforts are developed, safety will remain a priority.

#### Vehicles

Survey/Interview participants listed a combined total of 82 vehicles. Approximately 28% of the vehicles are wheelchair accessible. A vehicle utilization table is provided at the end of this chapter (Table 6). Many transportation providers did not provide information for the Vehicle Utilization Form but provided information regarding the number of vehicles and wheel chair accessible vehicles in their fleets. Those numbers are reflected in the total amount of vehicles listed above and in the remainder of this document.

### Summary of Existing Resources

An overall summary of existing resources and an inventory of current services allows better insight into opportunities to coordinate services and the transportation gaps currently in Hocking County.

Prior to 2007, the City of Logan used a cab company to provide some limited transportation to community members. None of the vehicles were accessible for individuals with disabilities. The community recognized the need for affordable and fully accessible transportation options and formed a Transportation Advisory Group. The TAG in cooperation with the City of Logan contacted Ohio Department of Transportation (ODOT) to assist in resolving the issue. Hocking Athens Perry Community Action (HAPCAP) was selected to explore their capacity in forming a public transit program for the City of Logan.

HAPCAP established Logan Public Transit (LPT) and in July 2007, began operations. The original fleet consisted of two vans and a small bus and service was provided to the City and individuals within two miles of the City limits. Over the past ten years, LPT expanded to ten vehicles in service including seven accessible vans and three lift equipped busses. In 2014, through the American Recovery and Reinvestment Act, LPT was able to purchase dispatching software, improving efficiency and timeliness of service delivery. In 2015, LPT expanded to include the Highway 33 corridor. This provided service to the villages of Haydenville and Rockbridge. In 2015, a contract with South-Central Ohio Job and Family Services enabled LPT to provide non-emergency medical transportation for eligible Medicaid enrolled individuals. The range for this contract allowed travel to Metro areas including Cleveland, Columbus and other cities in central Ohio. In 2016, with ODOT concurrence, LPT expanded the service area to include about 100 square miles in the northeast section of the County. This included service to the villages of Carbon Hill and Union Furnace and established a new fare zone to keep fares equitable across the service area and provided service to over half the county population. In 2017, LPT was qualified to provide service to individuals with disabilities under the "Waiver" program administered by the Ohio Department of Developmental Disabilities. In 2018, LPT was awarded a contract under the Older American's Act administered by the Area on Aging. This service for individuals 60 and older is intended to keep individuals in their residence as long as possible by transporting them to medical facilities, social needs and other appointments necessary for independent living. In addition, LPT was part of the State's TIGER initiative upgraded scheduling and dispatching software in 2018. In January 2020, LPT expanded coverage to the entire county with three zones, right before the beginning of COVID. Currently ridership is almost the same as pre-pandemic rates, but ridership diminished during COVID and LPT initiated safety measures to protect riders.

Logan Public Transit works closely with county social service agencies, other non-profits and commercial providers in an effort to provide essential services. Since established, Logan Public Transit with support from HAPCAP, continues efforts in expanding services to meet the needs of county residents with safe, affordable and reliable transportation options. Service providers around the county work together when possible to meet the needs. Rules and regulations at times prohibit true coordination of services.

Funding for LPT is a serious concern. Changes with non-emergency medical transportation across the state could have a major impact on LPT. LPT must continue to seek new contract options, donations and other funding to continue to provide service at the current levels as they continue to prepare for the changing landscape.

Hocking County has limited public and private transportation providers, with some services serving clients who qualify under certain criteria or are associated with the organization and its services, and other providers servicing the public with no requirements.

The summary of existing resources illustrates gaps in services in the county including:

- Limited county-wide affordable services.
- A lack of availability of affordable and accessible services on the weekends, early morning and evening hours during the week.
- Limited wheelchair accessible vehicles publicly available.
- Private transportation providers to cover gaps in public transit services. (Note a few for profit bus companies have been developed but focused on group trips for tourists.)
- Limited transportation services that operate within & outside of Hocking County.
- A need for the coordination of efforts within & outside of Hocking County.

In addition, the City of Logan and Hocking County face the same issues as many rural areas throughout the US. A loss of manufacturing jobs and a struggling downtown. There is a collaborative effort in the community to revitalize the downtown with a focus on small business development for the large tourism trade and re-building the downtown historic theater. Thereby enhancing opportunities for residents and the high volume of out of town visitors to enjoy social and commercial activities in Logan.

The infrastructure is aging and shows many signs of deterioration. Elected officials make every effort to fix what funding allows, but there are more issues than funding can repair in a timely manner. To enhance quality of life and improve transportation options, the residents have expressed interest in bike paths/lanes, sidewalks for walking and safety, additional parking in the downtown and safer intersections. For those with disabilities, better street lighting, curb cuts and visual/audible indicators at cross walks would better service community members. As our county's average age increases, the need for better and wider lane makings, better road signage and possibly islands at cross walks would improve safety.

Most of these needs are "shovel ready" and could be in progress with a minimal amount of engineering/planning. As a "destination" for millions of visitors to the surrounding state parks, trails and nature/game preserves, the improvements would be a basis for a model Ohio small city and showcase Ohio's efforts in supporting Smart/Livable City initiatives.

### IV. Assessment of Transportation Needs and Gaps

In an effort to better understand the needs in Hocking County, the planning committee examined research and data, as well as solicited input from the community to gather information about needs and gaps in transportation services.

The demographic and socio-economic conditions of the study area are discussed in the Demographics Chapter of this plan. The following overview is an evaluation of the gaps in service based upon geographic data as well as from the perspective of the targeted populations, transportation providers, and the general public.

A variety of stakeholders were interviewed in the area in an attempt to solicit input and request participation from any organization that could potentially be impacted by the coordinated transportation planning process.

The following methods were used to assess transportation needs and gaps

- Assessment of data and demographics
- Release of two transportation surveys to the county focused on:
  - o General Public
  - Express
- Two Public Transportation Meetings held one in Logan and one in Laurelville
- Focus Groups with target population (seniors and individuals with disabilities)
- One-on-one interviews with providers and referring agencies


### Local Demographic and Socio-Economic Data

Data for each target population group were aggregated by Census Block Group for transportation analysis. The demographic and socio-economic data is valuable because a comparison of where the highest and lowest densities individuals who are most likely to need transportation live. This information can then be compared to the locations of (1) major trip generators, and (2) available transportation services.

The following exhibit **1** illustrates the population density of Individuals Age 65 and Older in Hocking County and regions of the county where these populations are found.

## People Aged 65 and Older Hocking County, Ohio




The exhibit below indicates the areas where the number of no vehicle households is above the Hocking County average. The absence of a vehicle in the household is often an indication of the need for transportation services.

**Exhibit 2: Map of Density of No Vehicle Households** 



### Analysis of Demographic Data

The density of individuals age 65 and older is concentrated in the central region of the county, markedly along the 33 corridor between the City of Logan and Rockbridge and in all outlying areas of the county, most notably in Salt Creek Township & surrounding Laurelville. These outlying areas have the least amount of affordable transportation options available to them. Many seniors in Hocking County reside outside of the city limits in areas further away from medical care facilities and senior services.

A high percentage of zero vehicle households lay along similar areas as seen in Table 1 revealing a population in need of transportation services or programs. The highest percentage of zero vehicle households are located within Logan city limit or right outside it.

Major trip generators are located mostly in the City of Logan. The rural areas of the county need to travel to the city or outside the county in order to gain access to job opportunities, medical facilities, food, educational institutions and more.

Based on the demographic data above, it is crucial that affordable transportation options are available for community members residing in the rural areas of the county, especially seniors and zero vehicle

households, in order to connect them to a variety of services available elsewhere in and outside the county.

### General Public and Stakeholder Meetings/Focus Groups

HAPCAP's Hocking County Mobility Manager hosted and facilitated two local meetings and four focus groups to discuss the unmet transportation needs and gaps in mobility and transportation. A few people participated in the accessible public meetings. Focus groups were held at the Scenic Hills Senior Center, Hocking Valley Industries, Home Away from Home and Fairfield Community Supports. More information about what meetings were held and attendance at those meetings is available upon request.

During the meeting, the HAPCAP Hocking County Mobility Manager presented highlights of historical coordinated transportation in Hocking County, and discussed the activities since the last Coordinated Public Transit Human Services Transportation Plan that have helped to address some of the unmet transportation needs and gaps in services for the area, specifically expansion of Logan Public Transit from two to three zones, essentially expanding to provide full coverage to all county residents and the hiring of a MM dedicated to the county. The focus of the discussion was transportation for older adults, individuals with disabilities, and people with low incomes. However, several topics discussed also impact mobility options for the general public.

Participants discussed numerous mobility issues to achieve, preserve, avoid, or eliminate through coordination during the meetings. Coordinated transportation stakeholders will consider these unmet needs when developing transportation goals and strategies, and grant applications. The exhibit at the end of this section provides a summary of the unmet mobility needs discussed during the meeting as well as the needs identified by the survey results.

### Surveys

The following survey summary includes the information gained from the following surveys that were performed. **369** surveys were completed:







## Q3 What city or village do you live in?







# Q7 If you are an individual with a disability or a senior (65+), do you receive discounted rates for Logan Public Transit?















# Q17 What days of the week are the most difficult for you to find transportation?









# Q21 Which providers have you received a ride from in the past year (check all that apply)



I find the sidewalks in Logan to be hazardous in some places, while in good repair elsewhere in the same block. Regarding transportation, it's been difficult getting family and friends to cover the various appointment times and locations. I need to take my wheelchair, as well, which is a complicating factor for both private and public transportation. Finally, I live on a country road, off the beaten path. Because of my condition, transportation has become important, a challenge, and more expensive. Fortunately, I am able to deal with these issues. But I know there are many others who cannot. 

## Final Insights and Analysis of Data

Hocking County reflects a poverty rate of 14.7%. Low-income individuals lacking transportation options have no access to medical facilities, grocery/shopping centers, social engagements with family and friends. A large number of respondents are currently not employed, likely in part due to little or no access to affordable transportation options connecting rural areas to the major trip generators in the city of Logan and other regions of the county.

Financial hardships also serve as a barrier for community members to access transportation options available to them due to their inability to pay for services and vehicle ownership (vehicle and maintenance, license, insurance, gas, etc).

Community members who wish to use services to commute to work or other locations are unable to do so because they:

- Live or work outside of the service area.
- Cannot afford to pay for services every day.
- The services do not run early enough, late enough.
- There is no weekend service.

Many community members are unaware of:

- The services available in their area.
- How to utilize these services.

Respondents who can utilize services do not because:

- The timeframes are inconvenient.
- The services do not run early enough, late enough, or on the weekends.
- They rely on family & friends at this time.

#### Strategies and Goals

- Extension of services hours to run earlier and later.
- Expansion of service days to include Saturday and Sunday.
- Additional capacity for door-to-door accessible van services.
- Lower or free fares.
- Outreach/promotion of services.
- More capacity to fulfill existing requests and needs.

## Public Meeting Insights and Notable Comments

The Hocking County Coordinated Plan Steering Committee decided to hold transportation round tables in different locations throughout the County in order to gain a focused understanding of certain areas' needs and gaps. If community members did not attend these round tables, the Hocking County Mobility Manager conducted transportation outreach questions to local groups and meetings to gain insight. Listed below are the notable discussions for each area with area specific priorities and goals that differ from the overall goals derived in the strategies and goals section of this document.

## Logan Public Meeting (Individuals w/ Disabilities Focused)

Tuesday, July 12, 6-7pm at the Logan Public Library

Attendees: 4, two from HAPCAP Transportation

The following items were discussed:

- One senior shared her use of public transit, Senior Center and Veteran's Service Commission
  Transportation. She is pleased with the service she receives, and has used them for years. She
  was a strong advocate for the various transportation options that she has, including friends. She
  also lives in town and shared that she walks many places and that the sidewalks are in better
  condition in certain areas than others.
- This led to a discussion with an attendee from Logan Daily News who shared that their intern walks to work and around walkability audits.

#### **Prioritized Goals for City of Logan:**

- Encouraging support of transportation options, beyond current hours of service.
- Need work on some sidewalks and accessibility features.
- Plant trees for shade for those who walk on the sidewalks during the summer, but be careful
  about selection/placement of trees roots causing the sidewalks to buckle. (Logan Tree
  Commission is aware.)

## Laurelville Public Meeting

Sunday, August 7, 2-3pm at Laurelville Public Library

There were no attendees at this meeting. The Hocking County Mobility team surveyed at the Laurelville CSFP distribution for low-income senior citizens and the Coordinator set up a booth at a local festival in the town in September.

The following findings in relation to individuals in the Village of Laurelville and surrounding area:

- Need work on sidewalks and accessibility in the village
- Extended out of county services, since Laurelville is located on the county line
- Conduct more outreach about current transportation services; many didn't know LPT covered the full county

## Challenges to Coordinated Transportation

In addition to identifying needs, the steering committee gathered information from stakeholders and used their own professional experience to identify challenges to providing coordinated transportation services. These challenges include the following:

- There is no shared collection of data on the trip denials and reasons why people can't be served across agencies in order to learn specifics about the actual depth of the problem.
- Transportation providers are working at nearly full capacity and are unable to consistently coordinate efforts.
- Transportation providers are currently not meeting together to share information and support one another.
- Different funding sources and calculating of fares are prohibitive for coordination of public and private efforts.

## Summary of Unmet Mobility Needs

The following table describes the identified unmet transportation needs that were identified and the method used to identify and prioritize each need. Needs are listed in order of their rank in highest to lowest priority.

## V. Goals and Strategies

## Developing Strategies to Address Gaps and Needs

Strategies for improving transportation for Hocking County should address the service gaps and user needs identified in this plan, if they are to be effective. As described, the gaps and unmet needs are based on information obtained from geographic analysis, the attendees participating in the meetings, and responses to the public surveys – general public and express.

Based on information gathered throughout the planning process, the following strategies were developed to address the gaps and unmet transportation needs. Priority levels are assigned by considering the primary funding sources that could be available to support plan implementation compared to the importance of meeting this unmet need expressed by the public and stakeholders. Not all strategies are activities specifically eligible for funding under the existing programs, nor is it guaranteed that sufficient funding will be available to achieve every strategy identified. In addition, the local stakeholders will need to provide support and commit to pursuing the strategies if they are to be

accomplished. Nonetheless, these prioritized strategies have been tailored to 5 of the identified primary barriers and unmet needs.

### Goal #1:

## INCREASED SUPPORT FOR TRANSPORTATION PROVIDERS TO HELP MAINTAIN AND EXPAND CURRENT SERVICES FOR HOCKING COUNTY

Need(s) Addressed: Affordable transportation services for seniors, individuals with disabilities, the workforce & general public, during business hours (Monday-Friday) and beyond standard business hours (early/late hours and weekends) (Need #1, 3). Securing local match for public transportation and mobility management (Need #2, 4, 6).

#### Strategy

Maintain and expand transportation services through ODOT's 5311, 5339 and possibly 5310 funding program, other state or federal funding streams, increased local support from city and county, increased contracting opportunities, and by pursuing grants and donations and increased advertising revenue, etc. Engage more strategic partners and stakeholders on the Transportation Advisory Committee.

Timeline for Implementation: January 2023 to December 2026.

#### **Action Steps:**

- Build up capacity for transportation services
- Request and advocate for 5311, 5339 and 5310 funding (ODOT)
- Collect stories and data to support the need, continue to survey the public (data collection on who transportation providers are not able to serve and why)
- Advocate for increased local match and explore additional city and county entities to provide funding
- Explore other funding sources, including grants
- Promote contracting opportunities
- Create a work group to explore expanding services

Parties Responsible for Leading Implementation: Hocking Athens Perry Community Action Transportation Division, Mobility Management, Work Group, Logan Public Transit

Parties Responsible for Supporting Implementation: Hocking County Transportation Providers, City/County Government and other funding partners

Resources needed: additional funding, staff time, contract services, building space, vehicles, publications or printing, local cash, technology, capital needs

Potential Cost Range: Variable

Potential Funding Sources: 5311, 5339, 5310 programs, Medicaid, foundations, advertising revenue, private donations, local government & community organizations, levy, tax income and others

Performance Measures/Targets:

- Active work group meeting at least 4 times per year
- Increase funding to maintain and expand transportation services
- Increase applications for funding
- Increase number of new contracts
- Increase advertising revenue
- Increase of service hours

## Goal #2:

#### **EDUCATION OF HOCKING COUNTY COMMUNITY ABOUT TRANSPORTATION OPTIONS**

Need(s) Addressed: Currently, there is a lack of knowledge about community transportation options and awareness of needs, a lack in coordination of services, limited advocacy for transportation, and utilization of services. (Need #2)

#### Strategy

Surveys, stakeholder meetings, steering committee and public meeting results have shown: an overall lack of knowledge of current transportation services available and a lack of coordination efforts between existing transportation providers in the county. An enhanced mobility program will provide education for the community, perform travel training, help connect individuals to transportation options, advocate for transportation in planning meetings and encourage the coordination of services in the county.

Timeline for Implementation: January 2023 to December 2026.

#### **Action Steps:**

- Continuation of Mobility Management program
- Identify 20% local match for Mobility Manager; apply to ODOT funding for other 80%
- Continue to meet with senior citizen groups at Senior Center and agencies supporting persons with disabilities and other vulnerable populations
- Create education campaign around transportation
- Continue to explore regional mobility coordination
- Create a Hocking-Athens MM Social Media Presence
- Create a work team with Athens Mobility Manager and Transportation Staff
- Utilize comprehensive county plan to enhance and promote our work

Parties Responsible for Leading Implementation: Mobility Manager, HAPCAP Transportation Division

Parties Responsible for Supporting Implementation: Hocking County, City of Logan, County Social Service Providers, Ohio Department of Transportation

Resources Needed: Funding Sources for Mobility Management programs, including Federal Transportation Programs, Ohio Department of Transportation, Hocking County, City of Logan, South Central Ohio JFS, Hocking County Board of DD, Hocking County Health Department, other Hocking County social service providers, foundation grants

Potential Cost Range: \$100,000

Potential Funding Sources: Federal Transportation Programs, Ohio Department of Transportation, Hocking County, City of Logan, Hocking County Children Services, South Central Department of Job & Family Services, Hocking County Board of Developmental Disabilities & other Social Service Providers.

#### Performance Measures/Targets:

- Build continued awareness and support for Hocking County Mobility Management Program
- Continue to track tabling opportunities at community events and expos throughout county to share info on Mobility Management and transportation options
- Increased funding to support transportation awareness and coordination and match for Mobility
   Management program
- Social media actively used to share information to public
- Mobility Team group meeting at least 12 times per year (once a month)

#### Goal #3:

#### CREATE A COUNTY-WIDE AND REGIONAL ACTIVE TRANSPORTATION PLAN

Need(s) Addressed: Lack of education, access, infrastructure, planning & policy, and data initiatives related to active transportation options and complete streets policies. (Need #4)

#### Strategy

Active transportation plans are dedicated to increasing the safety of active transportation users and increase the number of residents participating in active transportation and the number of active transportation options. These plans include a variety of goals such as implementing Complete Streets policies, creating safe pedestrian crossings and walks, and creating and expanding bike paths and lane infrastructure. Based on community survey and discussions with stakeholders, the county could benefit from an Active Transportation Plan.

Timeline for Implementation: Present to December 2026

#### Action Steps:

- Initially, create an Active Transportation work group, meeting at least quarterly
- Team creates an Active Transportation Plan
- Team conducts research, outreach, education, and advocacy regarding the Active Transportation Plan and explores funding options
- Team explores a pedestrian safety campaign, sidewalk audits
- Team encourages Complete Streets policies adopted in Hocking County

Parties Responsible for Leading Implementation: HAPCAP Mobility until lead agency identified by Active Transportation Work Group

Parties Responsible for Supporting Implementation: Ohio Department of Transportation, Ohio Department of Health, Health and Human Services, Local Government Entities (Commissioners, Township Trustees, City Council)

Resources Needed: Funding, staff time, building space, publications and printing, local cash, capital needs

Potential Cost Range: Project dependent. Access free technical assistance from Ohio Department of Transportation

Potential Funding Sources: Ohio Department of Natural Resources, Ohio Department of Health, Community Foundations, City of Logan, Hocking County, Buckeye Hills Regional Transportation Planning Organization, Ohio Department of Transportation currently funding a bikeway study from Nelsonville to Logan

### Performance Measures/Targets:

- Creation of Active Transportation Work Group with meetings at least quarterly
- Creation of Active Transportation Plan by Work Group
- Track number of Active Transportation related events
- Funding awarded for projects
- Number of Complete Streets policies adopted in county

### Goal #4:

## WORK WITH SOUTH-EAST OHIO MOBILITY MANAGERS TO PROMOTE REGIONALIZATION OF TRANSPORTATION OPTIONS

Need(s) Addressed: As shown in the surveys and from calls received by current Mobility Coordinator, there is a need for more reasonable cost out of county trips. (Need #2,3)

#### Strategy

Working with other Mobility Managers in Region 8 and other neighboring counties, come up with a plan to offer reasonable trips out of county. Look into other funding sources, like foundation grants, to help cover transportation costs for out of county trips not covered by Medicaid NET.

Timeline for Implementation: Present to December 2026

#### **Action Steps:**

- Create tracking tool to capture trips that are being denied due to lack of service out of county borders
- Discuss regional transportation needs at Region 8/Buckeye Hills meetings and discuss options
- Meet with mobility managers in neighboring counties outside of Region 8 area and discuss options

Parties Responsible for Leading Implementation: HAPCAP Mobility, Region 8, Buckeye Hills

Parties Responsible for Supporting Implementation: Ohio Mobility Management, Ohio Department of Transportation

Resources Needed: Funding, meeting space, travel expenses, publication and printing

Potential Cost Range: Dependent on projects

Potential Funding Sources: Buckeye Hills, Ohio Department of Transportation, Federal Transportation Programs

Performance Measures/Targets:

- Create regional coordinated transportation plan
- Continue meeting quarterly with Region 8 Mobility Managers
- Meet at least once per year with all Mobility Managers whose counties border Hocking
- Tracking tool created and utilized

## VI. Plan Adoption

The ODOT Office of Transit requires that all locally adopted coordinated public transit human services transportation plans be developed according to a stated planning process. The previous version of Hocking County Coordinated Transportation Plan was developed internally and adopted at the end of 2018. The plan was re-written internally in 2022, open for 30 day public review, and votes and adopted by the Hocking County Steering Committee, a group of local organizations including representatives of senior citizens, persons with disabilities and low income population on December 29, 2022. The annual updates (2023, 2024, 2025) and development going forward is as follows:

- The Mobility Manager will facilitate public meetings, focus groups and quarterly stakeholder meetings.
- The Mobility Manager will create a public survey and distribute surveys at all meetings and public functions for part of the year.
- A survey will be make available on the HAPCAP Mobility website and promoted through local media sources, including social media.
- The Mobility Manager will distribute surveys to focus groups at senior centers and agencies who serve people with disabilities.
- The Mobility Manager will attend all work group meetings listed in the plan and keep track of progress on goals/strategies.
- The Transportation Steering Committee will discuss any changes needed based on progress from work groups or new survey information.
- Any changes will follow the Amendment Process.

The Hocking County Coordinated Plan Steering Committee actively participated in the creation and adoption of this document.

## Appendix C: Definitions

There are several terms used throughout the plan that may be unique to transportation providers or human service agencies. The terms are defined here for reference.

**Coordination** – Collaborative efforts toward understanding and meeting the mobility needs in the most appropriate, cost effective, and responsive manner.

**FAST Act** – Congress established the funding for Federal Transit Administration programs through authorizing legislation that amends Chapter 53 of Title 49 of the U.S. Code. On December 4, 2015, President Obama signed the Fixing America's Surface Transportation (FAST) Act, reauthorizing surface transportation programs through Fiscal Year 2020.

**Gaps in Service** – A break in the continuity of available transportation resources such as a break between hours of operation or a break between two or more geographic areas.

**Lead Agency** – The organization responsible for facilitating outreach; composing a plan that meets the requirements of current Federal and State legislation; maintaining documentation from the planning process and making it available upon request; and leading stakeholders through annual reviews, amendments, and updates of the plan. The Lead Agency also is responsible for submitting the adopted Coordinated Plan and all amendments or updates to participating stakeholders and ODOT.

**Planning Committee/aka Steering Committee** –The Steering Committee is composed of key community stakeholders. The Steering Committee members agree to actively participate in the planning process and act as the plan advisory and adopting entity.

**Ridership** – The total number of passengers who boarded transportation vehicles are counted each time they board a vehicle.

**Section 5310 Program** — Enhanced Mobility of Seniors & Individuals with Disabilities (49 U.S.C. 5310) provides Federal formula funding for the purpose of assisting private nonprofit groups in meeting the transportation needs of older adults and people with disabilities when the transportation service provided is unavailable, insufficient, or inappropriate to meeting these needs. The program aims to improve mobility for seniors and individuals with disabilities by removing barriers to transportation service and expanding transportation mobility options.

**Section 5311 Program** – The Formula Grants for Rural Areas program provides capital, planning, and operating assistance to states to support public transportation in rural areas with populations of less than 50,000 where many residents often rely on public transit to reach their destinations. The program also provides funding for state and national training and technical assistance through the Rural

Transportation Assistance Program. Sub recipients may include state or local government authorities, nonprofit organizations, and operators of public transportation or intercity bus service.

**Section 5307 Program** – The Urbanized Area Formula Grants program (49 U.S.C. 5307) makes federal resources available to urbanized areas and to governors for transit capital and operating assistance in urbanized areas and for transportation-related planning. An urbanized area is an incorporated area with a population of 50,000 or more.

**Transportation** – Transportation is broadly defined to include traditional transit, human service agency services, on-demand (taxi-like) services, bicycle and pedestrian programs and amenities.

**Unmet Transportation Needs** – Transportation that is wanted or desired but is not currently available.
